Animal Control Academy

Two of our Field Officers graduated from the Animal Control Academy hosted by the Washington State Criminal Justice Training Commission (WSCJTC) and Washington Animal Control Association (WACA). This 80-hour intensive course is held at the WSCJTC center in Burien, Washington and is specifically designed for Animal Control Officers. Instructors consist of WACA personnel who will cover a variety of topics to satisfy Washington State's Animal Control Officer Requirements. Topics covered in the 80-hour course included:

Animal Control and Care:

- Capture & Restraint
- Wildlife Identification & Handling
- State & Local Animal Laws
- Animal Diseases and First Aid
- Blood Sports

Traditional Law Enforcement:

- Court Room Procedures
- Ethics
- Crisis Intervention
- Criminal Law
- Search & Seizure







Sewer Repair

Unfortunately the sewer repair is taking longer than originally estimated. Our one week closure, turned into two weeks. There were some setbacks once the plumbers saw how the original plumbing was installed. The pipes were cemented into the foundation, and cutting them out took longer than anticipated. We reopened to the public on Wednesday, March 29th. The flooring in the bathrooms, treatment, and cat isolation were completed March 31, and the tile will be replaced in the lobby April 3rd and 4th. We will be closed to the public Tuesday April 4th for the installation.
